

Addendum, Additions and Corrections

Lot 125 – Addendum. The cuvette is missing. The hinge is present.

Lot 125 – Correction. Date of last service was more recent, in September 2016 (not 2014). See photograph of service invoice, which is included with the watch.

Lot 149 – Corrections and Addendum. 1. The bezel is 14K gold (not 18K). 2. The bracelet is stainless and 14K gold (not 18K). 3. The bracelet is ref 62523-**H14** (the -H14 was not included previously).

Lot 196 – Correction. Upon proper levelling, the clock has run (and continues to run) for over 60 hours as we add this correction.

Lot 275 – Addition/Addendum. The consignor has located the watch’s original inner and outer boxes as well as its original paperwork and factory label which lists the watch as 18K Coral gold. Inner and outer boxes show hardly any wear. Estimate is increased from \$1,500-3,000 to \$2,000-4,000.

Lot 330 – Withdrawn.

Lot 331 – Correction. The dial has been relumed over the original luminous paint.

Lot 332 – Correction. The dial has been relumed over the original luminous paint.

Lot 549 – Addendum. The dial appears to be refinished.
